**EXTRACT FROM THE STATUTE:**

**Article 3.1**

(a) All persons, not being Prohibited persons or Public officers, who are or were engaged in any form of commercial, industrial or services activities in or from Malta, are eligible for membership.

(b) A person shall be admitted to membership of the Malta Chamber only once. He shall not be eligible to a second or multiple memberships. Provided that a Corporate Member of the type referred to in Article 3.7(a) (iii) of this Statute may, when nominating persons as Individual Members in terms of Article 3.7(b) and (c) of this Statute, nominate persons who are already existing Individual Members of the Malta Chamber, but such second or multiple membership will not entitle the said nominated persons to a second or additional vote.

(c) Membership shall not be transferable.

**Article 3.7**

(a) Corporate Membership is open to persons who are not physical persons, including, in particular: (i) Any Company; (ii) Any Partnership; and (iii) Any form of association, foundation, business chamber, organisation or body of persons established and effectively managed and controlled in Malta other than of the type of (i) and (ii) above.
